- All rentals must be made 2 weeks in advance. $\qquad$
- A rental agreement, full rental fee and refundable damage deposit must ALL be made at the same time to book the party for the date specified. We WILL NOT hold the spot without payment or damage deposit. $\qquad$
- A refundable damage deposit of $\$ 250$ is mandatory to rent the Outdoor Pool facility. If the facility is left in the shape that you found it in, the full amount will be refunded. If not, $25 \%, 50 \%, 75 \%$, or $100 \%$ will be charged for damage or trash left behind. $\qquad$
- Deposits can be made in the form of a check, money order, or cash only. Credit cards or debit cards are not allowed for the deposit but can be used for the rental. $\qquad$
- There are no rentals during normal business hours of 12:00pm-6:00pm Monday through Saturday and 1:00 pm-5:00pm on Sundays. $\qquad$

- Rentals are in 2-hour blocks and only one rental will be booked at a time. $\qquad$
- Rentals can be booked any day of the week if that day is available. $\qquad$
- There will be different rental rates based on amenities desired by the renter. $\qquad$
- All parties Monday through Saturday will be $6: 15 \mathrm{pm}$ to $8: 15 \mathrm{pm}$. $\qquad$
- Parties on Sunday can be chosen between 10:45am to $12: 45$ pm or $5: 15 \mathrm{pm}$ to $7: 15 \mathrm{pm}$.
- The Concession Stand will not be available during your event. You may bring food and drinks. $\qquad$
- All food must stay in the concession picnic area and any drinks leaving the concession picnic area must have a lid.
- Alcohol is NOT allowed. $\qquad$
- All children who are not toilet-trained shall wear tightly fitting disposable swim diapers. $\qquad$
- Appropriate swim attire only. Street clothes and street shoes are not permitted in the pool. No cutoff jeans or gym shorts are allowed. $\qquad$
- Only US Coast Guard certified flotation devices are allowed in the pool area. Inflatable flotations are NOT allowed. $\qquad$
- Pool rules are posted at the entrance to the pool. ALL participants must follow all posted rules. $\qquad$
- At the YMCA's discretion, groups may be required to provide a Certificate of Insurance naming the YMCA as an additional insured. Coverage extended to the YMCA shall not be less than \$1,000,000 and shall be provided and attached to the signed facility agreement.
