## Parents, have you heard of <u>YMCA Corporate Membership?</u>

<u>Corporate Membership</u> is a YMCA Membership connected to your place of work (for those who qualify). Corporate Membership gives you a waived Join Fee when you begin your membership at the <u>Warren County YMCA</u>, as well as a 10% discount on monthly membership fees (15% if your business/place of employment has enough participants doing Corporate Memberships). Payments for your membership are either taken directly from your <u>PAYCHECK</u> <u>(for CORPORATE PARTNERS that offer this)</u>, or by receiving the <u>discount in-house</u> here at the <u>Warren County YMCA</u> and setting up Monthly, Quarterly, Semi-Annual or Annual membership payments. (<u>Monthly payments must be set to automatically be withdrawn</u> <u>monthly via a Credit/Debit Card or Bank Account.</u>)

### How does this affect my child participating in Youth Sports at the Warren County YMCA?

If you currently have or open a new <u>FAMILY or SINGLE PARENT</u> Corporate Membership with the <u>Warren County YMCA</u>, your child(ren), who will be active on the account, will be eligible to be registered for Warren County YMCA Youth Sports...FOR FREE! <u>\*THIS DOES NOT INCLUDE</u> <u>YOUTH SWIM LESSONS, TUMBLING, AFTER SCHOOL PROGRAM OR CAMP MESKWAKI DAYCAMP</u>.

Your child(ren) MUST live in the same household as the membership holder.
